



VISITING BOXER LICENSE



This is **PAGE 1** of an **APPLICATION** for a **SAN VISITING BOXER LICENSE AND ANTI-DOPING AGREEMENT** required for a professional boxing contest in Finland supervised by Suomen Ammattinyrkkeilyliitto (SAN).

PAGE 1 must be submitted to SAN by email no later than SEVEN DAYS PRIOR to the contest.

PAGE 1 must be filled in and signed by the Boxer or by the Boxer's official representative (Manager or Agent).

PAGE 2 will be available separately and must be submitted no later than the day prior to the contest.

PAGE 3 will be available separately and must be signed by the Boxer and the Chief Second in Finland.

1. THE LICENCE APPLIED FOR

I respectfully request SAN to grant me a Visiting Boxer's License

Visiting Boxer's Licence – Required from 1.1.2025 onwards for all boxers with a foreign license boxing in Finland in a professional boxing contest supervised by Suomen Ammattinyrkkeilyliitto (The Professional Boxing Federation of Finland).

Validity – This License is valid solely for the purpose of one contest specified in this document. It's validity starts from the moment of signing page 3 of this agreement that can never be later than the day prior to the contest and validity can never exceed the duration of stay in Finland for the purpose of the specific contest, against the specific opponent, on the specific date, at the specific location specified in this document. This License does not invalidate the license from Boxer's licensing home commission, not even for the duration of the contest it is issued for.

Issuing – This License may be issued subject to medical approval along with Authorization to Box Abroad from the Boxer's licensing home commission issued for this specific contest.
