10. ANTI-DOPING AGREEMENT

Boxer - I hereby apply for a Visiting Boxer Licence for the contest specified on page one of this application.

Boxer and Chief Second - If this licence is granted, I agree to be bound and adhere to the Rules and Regulations and Official Instructions of Suomen Ammattinyrkkeilyliitto ry (SAN / Professional Boxing Federation of Finland), as published. I agree to be bound and adhere to the World Anti-Doping Code, as published. I have been offered the opportunity to familiarize myself with the above-mentioned rules well in advance, on the website san-proboxing.fi/fairfight, or otherwise. I agree to cooperate fully with any World Anti-Doping Code compliant anti-doping investigations or proceedings, whether concluded by FINCIS (Finnish Center for Integrity in Sports) or any other competent body.
